ORDER GRANTING PLAINTIFF'S EX PARTE MOTION FOR ENFORCEMENT OF SETTLEMENT AGREEMENT AND FOR ENTRY OF FINAL DEFAULT JUDGMENT IN THE AMOUNT OF ONE HUNDRED THIRTY-FIVE THOUSAND DOLLARS AND ZERO CENTS AGAINST THE DEFENDANT, ROBERT FLETCHER, AND ALL CORPORATE DEFENDANTS AND FINAL DEFAULT JUDGMENT AGAINST THE DEFENDANT, ROBERT FLETCHER, AND ALL CORPORATE DEFENDANTS

THIS CAUSE having come before the Court on *Plaintiff's Ex Parte Motion for Enforcement of Settlement Agreement and for Entry of Final Default Judgment in the Amount of One Hundred Thirty-Five Thousand Dollars and Zero Cents (\$135,000.00) Against the Defendant, Robert Fletcher, and All Corporate Defendants*, and the Court being fully advised in the premises, *✓*

THE COURT MAKES THE FOLLOWING FINDINGS OF FACT:

1. The Parties entered into a Settlement Agreement on February 7, 2014.
2. All Defendants to this cause of action agreed to be bound by the terms and conditions of the Settlement Agreement.
3. Pursuant to Paragraphs 13 through 15 of the Settlement Agreement, the Defendants, Robert Fletcher and all Corporate Defendants, were obligated to pay the Plaintiff a total of One Hundred Thirty-Five Thousand Dollars and Zero Cents (\$135,00.00), which was to be paid as follows:
 - A. \$10,000.00 in current and future attorneys' fees, investigative fees and/or costs; and
 - B. \$125,000.00 in Consumer Restitution.
4. All proceeds were required to be paid by these Defendants either simultaneously to the signing of the Settlement Agreement by these Defendants or alternatively, no later than February 14, 2014.

✓ The motion was noticed for hearing and counsel for the Defendants appeared to oppose the motion.

5. The Defendants timely paid the \$10,000.00 in current and future attorneys' fees, investigative fees and/or costs in compliance with the terms and conditions of the Settlement Agreement.
6. However, the Court finds that the Defendant, Robert Fletcher, along with all Corporate Defendants did not pay the required Consumer Restitution in the amount of One Hundred Thousand Twenty-Five Dollars and Zero Cents (\$125,000.00) pursuant to the terms and conditions of the Settlement Agreement and that these Defendants are now subject to the penalties detailed in the Settlement Agreement at Page 11, Paragraph 17.
7. The Court further finds that pursuant to the terms and conditions of the Settlement Agreement, at Page 11, Paragraph 17, the Defendant, Robert Fletcher, along with all Corporate Defendants, agreed that their failure to make any payment required by the Settlement and the subsequent filing of an affidavit by an Assistant Attorney General reflecting the failure of these Defendants to comply with the payment schedule imposed in the Settlement Agreement would result in the uncontested imposition by this Court of a Final Default Judgment against the Defendant, Robert Fletcher, along with all Corporate Defendants, in the amount of One Hundred Thirty-Five Thousand Dollars and Zero Cents (\$135,000.00).
8. The Court, moreover, finds that an affidavit was in fact filed as required by an Assistant Attorney General reflecting the failure of the Defendant, Robert Fletcher, along with all Corporate Defendants, to comply with the payment schedule imposed in the Settlement Agreement.

ACCORDINGLY, the Court now **GRANTS** the *Plaintiff's Ex Parte Motion for Enforcement of Settlement Agreement and for Entry of Final Default Judgment in the Amount of One Hundred Thirty-Five Thousand Dollars and Zero Cents (\$135,000.00)* Against the Defendant, Robert Fletcher, and All Corporate Defendants, and now enters a **Final Default Judgment** against the Defendant, Robert M. Fletcher, and all the below-cited corporate Defendants which were named herein.

It is hereby **ORDERED and ADJUDGED** as follows:

9. Judgment is issued in favor of the Plaintiff, **STATE OF FLORIDA, OFFICE OF THE ATTORNEY GENERAL, DEPARTMENT OF LEGAL AFFAIRS**, against the below-listed Defendants, and the Plaintiff shall recover from the below-listed Defendants, jointly and severally, the amount of **ONE HUNDRED THIRTY-FIVE THOUSAND DOLLARS AND ZERO CENTS (\$135,000.00)**, with interest, accruing at the statutory rate, for which **LET EXECUTION ISSUE:**
